The nature of the reliefs sought by the Plaintiff are as follows:

1. A declaration that on a true and proper interpretation of Articles 202(1), 202(2), 202(3) of the 1992 Constitution; Section 3 of the Police Service Act, 1970 (Act 350) and Regulations 2, 6(1), 6(2), 6(3)

and 6(4) of the Police Service Regulations, 2012 (C.I. 76), the creation of the office of Deputy Inspector-General of Police In Charge of Operations by the President of the Republic is unconstitutional, null and void.

2. A further declaration that on a true and proper interpretation of Articles 202(1), 202(2), 202(3) of the 1992 Constitution; Section 3 of the Police Service Act, 1970 (Act 350) and Regulation 6(1), 6(2), 6(3) and 6(4) of the Police Service Regulations, 2012 (C.I. 76), the appointment of Commissioner of Police (COP) Mr. Christian Tetteh Yohuno as Deputy Inspector-General of Police In Charge of Operations by the President of the Republic of Ghana is unconstitutional, null, and void.
3. An order restraining Commissioner of Police (COP) Mr. Christian Tetteh Yohuno from acting or purporting to act as Deputy Inspector-General of Police In Charge of Operations.
4. A further order restraining the Inspector General of Police or any command under him from accepting, relating to and/or issuing instructions or commands to COP Mr. Christian Tetteh Yohuno in his assumed capacity as Deputy Inspector -General of Police In Charge of Operations.
5. Any further relief(s), order(s) or direction(s) as this Honourable Court may deem just and proper.

The Plaintiff brings this action as a citizen of the Republic of Ghana pursuant to Article 2(1) of the 1992 Constitution of the Republic of Ghana.
